

EDUCATION

The center was established with the aim of providing remedial education to children with learning difficulties in English, Mathematics, and Science. Since then, the program has evolved each year, moving beyond mere academic exchange between children and teachers. It now addresses the needs of children from the nearby community who struggle to acquire the optimal level of knowledge and skills, which ultimately hinders their academic achievement and overall personality development.

In the 2023-24 academic year, the center catered to 528 children from grades 1 to 10, including 237 boys and 291 girls. At the center, students are given opportunities not only to achieve academic excellence but also to develop life skills through extracurricular activities, which help boost their self-confidence and enhance their personalities. The center is well-equipped with classrooms, laboratories, libraries, indoor games. Additionally, all children are provided with meals every day.

This community-based education center serves students from grades 1 to 10, focusing on those with learning difficulties in English, Mathematics, and Science. In addition to academic support, the center offers psychological counseling, career counseling, and health camps to further support the students.

DE-ADDICTION CENTER, TITWALA



From September 2008 to November 2014, we established our own detoxification and rehabilitation center in Titwala, Thane District. In 2014, Don Bosco graciously provided us with premises in Lonavala, where we operated a De-Addiction Center for 10 years.

In January 2022, we relocated from Lonavala back to Titwala. Currently, the Jeevan Dhara Addiction Centre is based in Mhaskal village, Titwala.

Our rehabilitation program spans 3 to 6 months, focusing on 'behavioral change,' with a dedicated emphasis on 52 specific behaviors. We serve patients struggling with addiction from across Mumbai, Pune, and various other states in India.







COMMUNITY WELFARE

We have distributed rations kits, medicines and blankets to the needy people of slums at Cheeta Camp, Sathe Nagar, and Mazgaon in collaboration with various organizations and individual donors.



STORIES OF CHANGE

Name of the Child: Sonali Dinanath Rajaram

Age: 15 yrs.

Sonali Dinanath, a 15-year-old 10th grader, has demonstrated remarkable resilience and determination over the past year. Sonali, who comes from a low-income family, is a living example of the strength of tenacity and supportive community. Sonali was completely ignorant of football a year ago. She was eager to experience new things. Her father is a security guard with salary of merely 10-12k, her mother is differently abled, and she has four sisters, therefore her family has encountered many difficulties. Due to financial hardships, Sonali was forced to look for other options for her education and personal growth because she could not afford her tuition. She then found Jeevan Dhara. Sonali became a part of Jeevan Dhara, a community project that provides resources and support to kids in similar situations. She was first introduced to football at this location. Sonali's curiosity was aroused, despite her initial ignorance of the sport, and she started taking part in football matches. Her commitment to the game increased, and she swiftly became more proficient on the field. She travelled a long distance to come to practice. Her younger sister joined the football program as well, motivated by Sonali. Sonali's dedication and enthusiasm for the sport spread throughout her neighborhood, inspiring other kids to pick it up. In addition to uniting the neighborhood, the children's burgeoning passion in football gave them a constructive and healthy outlet. Sonali also experienced a favorable change in her academic life. She was able to appropriately balance her studies with her newfound love of football because of Jeevan Dhara's assistance. In addition to seeing an improvement in her academics, she also gained self-assurance in her skills outside of the classroom. Sonali is doing better than ever at football in addition to doing exceptionally well in her schoolwork right now. Her narrative of overcoming hardship serves as an example of how both individual willpower and group support may result in noteworthy accomplishments. Sonali Dinanath is achieving success in life, demonstrating that everything is achievable with the correct circumstances and a strong determination.

We at Jeevan Dhara tirelessly supported Omkar, accompanying him and his parents to several schools until he finally secured admission. However, the school's distance posed a new challenge. Understanding their plight, Jeevan Dhara provided Omkar with a bicycle, easing his long travel. Riding his new bicycle each morning, Omkar felt a renewed sense of purpose. He thrived in school and found joy in joining Jeevan Dhara's football team, where he discovered a passion for the sport. The field became his sanctuary, building his confidence and camaraderie with teammates. Omkar's life transformed through Jeevan Dhara's unwavering support. Their intervention ensured his education, facilitated his commute, and nurtured his talents. 





